



\$100 “Refer A Friend” Claim Form

STEP 1 - Read The Policies

Place a “tick” mark in each box to indicate that you have read and understood the policies:

- In order to qualify for the \$100 Refer A Friend incentive, you must be a former SCRAP-IT client. This means you were the registered owner of a vehicle that you scrapped with our program, and your application was received by us between the dates January 1, 2008 and January 15, 2012.
- When you Refer A Friend you are considered to be the “Referrer.” The person who applies to our program after being referred by you is considered to be the “New Client.”
- The Referrer must complete and submit this \$100 Refer A Friend claim form with the New Client’s application.
- The New Client’s application must be received by us and dated January 15, 2012 or onward.
- The Referrer may refer a family member, aunt, uncle, cousin, neighbor, co-worker, or anyone they know who owns a 1995 or older vehicle (with a minimum of 6 months continuous insurance), that they wish to scrap.
- New Clients must, in all cases, meet, understand and agree to our program’s policies.
- In the case of family member referrals, the \$100 incentive will ALWAYS be paid to the Referrer. For example: Dad (Referrer) refers Son (New Client) who is the registered owner of a vehicle. Son buys a new vehicle and qualifies for a \$600 incentive. Dad will receive a cheque for \$100 and Son will receive a cheque for \$600. For financial control and audit reasons, we WILL NOT under any circumstances issue a cheque to Son for \$700.
- Joint or co-owners of a vehicle (identified on the registration) may not refer each other. There are NO exceptions to this policy.
- Business vehicles do not qualify for the Refer A Friend incentive.
- The New Client must complete the entire process – apply, scrap, claim. At which time both the Referrer and the New Client will be issued a cheque.
- This promotion ends on March 31, 2012. Applications received AFTER March 31, 2012 will not be eligible for the Refer A Friend incentive.
- SCRAP-IT reserves the right to limit the number of referrals any one Referee can make. SCRAP-IT reserves the right to cancel or extend this promotion at any time at its sole discretion as it is directly related to funding availability.
